

Grow Community – ADX Sydney 2026 – ‘Want to win an Oura Ring 4? At ADX Sydney 2026’

Terms and Conditions:

These Terms & Conditions govern the Grow Community ‘Want to win an Oura Ring 4? At ADX Sydney 2026’ Competition (the “Competition”) being conducted by Grow Management Pty Ltd ABN 55617707212. Entry to the competition is open only to Grow Community members that register and enter the ‘Want to win an Oura Ring 4?’ competition during ADX Sydney 2026. To participate in the Competition, eligible persons must complete and submit the contact form available here. There must be a minimum of 40 entries for the prize to be awarded. The prize is an Oura Ring 4 in Silver or Black (valued at AUD\$569).

Entry Eligibility: Open only to Delegates of ADX Sydney 2026. Entrants must be at least 18 years or older at the time of entry, be a dentist registered in Australia and hold an AHPRA number. Entry into the promotion is free. Entrants must have their own mobile device that is able to read QR codes. Employees of the Promoter and its related entities, and their immediate family members, are not eligible to enter the Promotion. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant’s identity, age and place of employment) and to disqualify any entrant who submits an entry that is incomplete, illegible, fraudulent, or not in accordance with these Terms & Conditions.

Maximum Entries: There is a limit of one (1) entry per person for the duration of the Promotion.

Entry Procedure: To enter the promotion, an eligible Entrant must: (1) visit the Grow Community stand (#295) at ADX Sydney 2026 (“Grow Community Stand”) during the promotional period; (2) scan the QR code using their mobile device; (3) register their details on the website linked from the QR code.

Prize draw: The winner will be determined by random draw conducted by Grow Management on Friday 03 April at 12pm (AEDT) at 11/151 Castlereagh Street, Sydney, NSW 2000.
